- 1. **Consideration, Discussion and Action:** To approve Ordinance No. 662 relating to the selling, growing, processing, warehousing, and storing of medical marijuana; creating Part 9, Chapter 8 of the Watonga City Code; adding zoning regulations for businesses involved in the selling, growing, processing, warehousing, and storing of medical marijuana; providing for repealer; savings; severability; and declaring an emergency.
- 2. **Consideration, Discussion and Action:** To approve Ordinance No. 663 amending the Watonga Code of Ordinances Part 3, Alcoholic Beverages, establishing regulations for licensure and occupational tax permits for selling alcoholic beverages and consistency with state laws and regulations effective October 1, 2018; and providing for the severability thereof.
- 3. **Consideration, Discussion and Action:** To approve Ordinance No. 664 modifying part Eight, Chapter One of the Code of Ordinances, City of Watonga, Oklahoma in relation to cleaning property within the municipal limits of trash, weeds, or grass; modifying said code to reflect current state law; setting fees associated with cleaning a property; providing for repealer; providing for severability; and declaring an emergency.

4. **Consideration, Discussion and Action:** To approve Ordinance No. 665 amending the Watonga City Code regarding truck driving and route restrictions for city streets; setting restrictions on use of streets by trucks; setting restrictions for parking on streets; providing for repealer; and providing for severability.
5. **Consideration, Discussion and Action:** To approve Ordinance No. 666 amending the Watonga City Code regarding the powers of the Library Board; removing duplicative language; renumbering remaining paragraphs.
6. **Consideration, Discussion and Action:** To approve Ordinance No. 667 amending the Watonga City Code to reflect that the Marshall and Street Commissioner are no longer elected positions within the City of Watonga; providing for repealer; and providing for severability.

8. **Consideration, Discussion and Action:** To approve Ordinance No. 669 amending the Watonga City Code to adopt the International Fire Code; providing for use of current fire code adopted by the Oklahoma Uniform Building Code Commission, as may be adopted from time to time; providing for repealer; and providing for severability.
9. **Consideration, Discussion and Action:** To approve Ordinance No. 670 amending the Watonga City Code to provide for City Council appointment of a Floodplain Administrator; providing for repealer; and providing for severability.
10. **Consideration, Discussion and Action:** To approve Ordinance No. 671 amending the Watonga City Code regarding the residency requirements for the Fire Chief, paid Firefighters, and Volunteer Firefighters; providing for repealer; and providing for severability.
11. **Consideration, Discussion and Action:** To approve Ordinance No. 672 modifying the Watonga City Code in relation to health hazards; amending definitions of health hazards; adding new language to allow partnership with the Oklahoma State Department of Health to enforce rules and regulations related to public health within the municipal boundaries of the City of Watonga; providing for repealer; and providing for severability.
